

Cookie policy

In compliance with the duty of information set forth in section 2 of article 22 of Law 34/2002 of 11th July on Information Society Services and Electronic Commerce, the purpose of this cookie policy is to provide you with clear and accurate information on the cookies used on the ACTA HOTELS SL website.

What are cookies?

Cookies are small files that websites send to your browser and download onto your computer. The cookies enable the website to store and retrieve information on your visit, such as your preferred language and other options, in order to improve the services on offer and to contribute to a better browsing experience for users.

Authorisation for the use of cookies

In accordance with the cookie notice displayed on the website, users accept that, by browsing the website, they grant their express consent to the use of cookies as outlined below, without detriment to the fact that they may modify the configuration of their browser to reject the use of cookies.

Types of cookies

Depending on the manager of the domain from which the cookies are sent and the data processed, a distinction is made between proprietary cookies and third-party cookies.

Cookies can also be classified in accordance with the period of time they are stored on the user's browser, with a distinction made between session cookies and persistent cookies.

Finally, depending on the purpose for which the collected information is processed, the cookies can be classified into the following categories:

Technical cookies: these enable the user to browse a website and use some of the services on offer (such as those that remember the items that make up a shopping cart).

Personalisation cookies: these enable the user to access the website with certain characteristics, such as the language.

Security cookies: these serve to prevent or hinder attacks suffered by the website.

Plug-in cookies for exchanging social contents: these allow the sharing of contents on social media.

Analytical cookies: these enable the manager to monitor the user's behaviour.

Advertising cookies: these permit management of the advertising spaces on the website.

Behavioural advertising cookies: like the previous ones, these are used to manage the website's advertising spaces upon the basis of the information collected on the user's behaviour and habits, adapting the advertising to the user's profile.

Geolocation cookies: these are used to ascertain the country where the user is located.

How to modify your cookie settings

You can restrict, block or delete the cookies of ACTA HOTELS SL or those of any other website by using your browser. The operation varies on each browser. To perform it you can use the help menu of your browser, which establishes the procedure for their removal.
